Commission Grants

The District of Columbia allows financial grantmaking by ANC Commissions using appropriated funds as long as they meet certain guidelines. In 2025, in addition to Commission review, the Office of Advisory Commissions (OANC) conducted a separate suitability review of any potential grantees prior to disbursement of funds.

In its FY 2025 budget, adopted in October 2024, ANC 7D had set out to disburse up to \$12,000 in grants to organizations approaching the Commission seeking support and subsequently determined to be eligible.

ANC 7D issued one grant using appropriated funds in 2025:

- **DCWise1** [501(c)(3), EIN # 47-1864286] - \$2,000 for a 7/19/25 Community Festival
 - Grant approved by OANC as permissible via 5/13/25 memo
 - Grant approved by ANC 7D in 6/10/25 virtual public meeting
